• Our first Board Meeting of the 2022/23 school year was held on September 13,

• The Board received as information a video summary

(https://www.youtube.com/watch?v=JrqqOI-027s) as part of the Superintendent's Report. Superintendent Boyce recapped a recent trip to Fort Chipewyan that included the historic signing of a Memorandum of Understanding between Athabasca Chipewyan First Nation, Mikisew Cree First Nation, and Fort Chipewyan Métis who will form their own Community Education Authority. PSD will operate Athabasca Delta Community School in the interim. The trip also included a visit from the Minister of Education, Adriana LaGrange who toured the school.

• The Board received and reviewed the 2022 Facilities Summer Work Report https://www.psd.ca/download/398594 as presented by Director of Facilities, Serge LaBrie. (48:39). Trustees had the opportunity to ask questions about noted projects for clarification and oversight. An overwhelming majority of school sites received upgrades and/or additions.

• The Board received as information the Where the World Opens Up Report https://www.psd.ca/download/398597 as presented by Associate Superintendent, Scott M. Johnston. (1:23:16). This newly titled report highlights the ways in which the school staff have opened up learning for students, including off-site destinations that hosted a variety of learning activities. From art galleries to music halls and The Court of Queen's Bench to swimming pools, programming extended beyond the school walls.

• The Board received as information the Human Resources 2021-2022 Report https://www.psd.ca/download/398595 as presented by Director, Human Resources, Shae Abba. (1:42:14). This is a comprehensive and thorough culmination of all aspects of Human Resources responsibilities. Staffing of all union and non-union employees, recruitment, occupational health and safety, retirement, health supports, negotiations and professional development all fall under the umbrella of the Human Resources department.

• As trustees we support the Division vision and mission for students. We act in a fiduciary manner by reviewing the reports from directors. Trustees establish, monitor and govern a system of education that fosters quality learning and wellness to support student achievement.

Information items:

-Attendance: 37% of our student body failed to meet the 87% attendance requirement. So we have introduced attendance incentives and rewards, including a 90% attendance award.

*Parent concerns were voiced about children wanting to attend school even when sick as they dont want any missed days to affect the outcome of them receiving the attendance incentives and rewards.

Approximately 1.5 days missed every 2 weeks will allow the 85% to be met. Attendance definitely has to be met. PSD, as well as parents are held accountable in regards to students attendance. Attendance is also very important as it can affect the need to have more counseling for overall mental health and also more support for the student within the classroom. PAT's for Wabamun school as a whole can also be affected by lack of attendance.

Staff did hold many conversations with the kids to see what would give them incentive to stay in school and want to attend.

-Things are going very well. We have been receiving feedback from parents. 18 students from Wabamun have signed up.
